Dear Friend of Pivot:

As you may be aware, our Anchor Recovery Center of Northern New York provides free addiction information and referral services, as well as support and resources for recovery from addictions, both for individuals suffering from addiction and their families. Each year the Center serves over 2,000 individuals and is the only formal addiction program that provides dedicated services for family members. So far, in 2023, the Center has provided more than 2,000 group services that support a healthy lifestyle and 595 employment coaching sessions to assist those in recovery seek gainful employment.

Again, this year we are asking for your help to preserve the free services we provide to families of those with addiction. The opioid epidemic continues, the need has never been greater. Each year over 400 families receive education, counseling, and support to help manage the addiction of a loved one; services that are not directly available at any other facility in our community.

Here is what Wanda W., a family member, said of the services offered at Anchor Recovery Center of Northern New York: "Anchor turned out to be a lifeline for me.
